- 3. The Charity and the Beneficiary agree that no interest shall be payable on the loan.
- 4. The Beneficiary covenants that the funds shall be exclusively utilized for the business of {*Nature of Business*}
- 5. As a pre-condition to obtaining the loan, the Beneficiary shall nominate a Sponsor who will sign an undertaking to monitor the Beneficiary's business and provide a bi-annual report to the Charity on the progress of the business.
- 6. In the event, that the Beneficiary is unable to repay the stated sum by the agreed date, the Beneficiary shall formally notify the Charity at least 30 days before the agreed repayment date stating reasons for the default.
- 7. The Charity upon receipt of the written notice from the Beneficiary shall review the reasons for the default and may grant an extension for the repayment of the sum where the Beneficiary provides justifiable reasons for the default.
- 8. The Beneficiary shall not assign or delegate its obligations without the consent of the Charity.
