

# **THE ANASIUDU FOUNDATION SCHOLARSHIP AGREEMENT**

**WHEREAS:**

1. The Foundation is committed to preserving and protecting the health of individuals who are in need of medical assistance and are unable to afford it. The Anasiudu Foundation Scholarship Programme is an initiative by the Foundation for the advancement of students who will ultimately help the Foundation provide health care services in the Foundation's treatment centre and support the vision to provide best patient care to individuals.
2. The Scholarship Programme is designed for less privileged students that have been admitted to faculty of Medicine, Pharmacy, Nursing and other Health science related courses in any university in Nigeria.
3. The Foundation has reviewed the Grantee's application and nominated the Grantee to receive a scholarship grant under the Anasiudu Foundation Scholarship Programme.
4. The Grantee has agreed to accept the grant based on the terms and conditions specified in this Contract.

**NOW IT IS HEREBY AGREED AS FOLLOWS:**

1. The Foundation grants Scholarship to the Grantee to enable him/her to pursue.....(Course)in.....(Faculty) of .....(University) for a duration of.....(number of years)
2. The grant issued by the Foundation shall cover only the Tuition fees for the Grantee.
3. The grantee shall provide a letter from his parents or legal guardian.

**4. OBLIGATIONS OF THE GRANTEE:**

- a) The Grantee will continuously maintain a good academic standard in his/her chosen field of Study.

- b) The Grantee undertakes to submit to the Foundation at the end of each session, an official transcript of grades, a yearly score card or its equivalent in their chosen courses.
- 5. In consideration of Grantee's receipt of a Scholarship, the Grantee shall after graduation and completion of all licensing requirement commits to provide service in the Foundation's treatment centre in primary care, general surgery and other needed specialty for the less privileged people.
- 6. The Grantee commits to working 30 days annually at no cost to the Foundation.
- 7. The Foundation reserves the right to revoke the scholarship at its discretion:
  - a. If the Grantee's cumulative grade point is less than 3.0 at the end of any session.
  - b. if the Grantee engages in malicious/undesirable activities or any form of misconduct that is unbecoming in the opinion of the Foundation.
